All that certain lot of land in Dunklin Township, Greenville County, South Carolina, containing 0.08 acres more or less according to survey and plat made by F. E. Ragsdale, Surveyor dated May 23rd and 26th, 1964 which shows the following courses and distances to-wit: BEGINNING at a point in center of a county road joint corner with Church property thence along line of Church property N. 52-35 E. 175 feet to I. P.; thence S. 26-08 E. 20 feet to I. P. thence S. 52-35 W. 175 feet to point in center of said road. Iron Pin on East side of road; thence N. 26-08 W. 20 feet to beginning corner.
