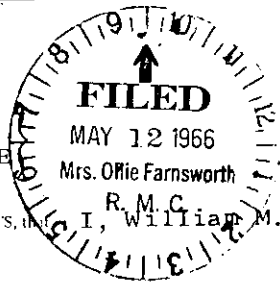

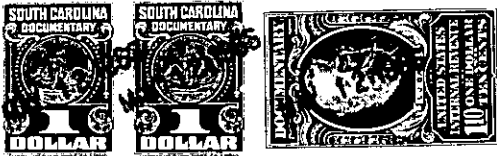
KNOW ALL MEN BY THESE PRESENTS, that I, William M. Edwards

in consideration of One Thousand and No/100 (\$1,000.00) Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Arthur A. and Gladese Cannon, their heirs and assigns.

All that piece, parcel or lot of land located, situated and being in Greenville County, State of South Carolina, known as Lot No. 1 in a subdivision known as Edwards Forest, Section 2, near Taylors, South Carolina, the same being shown on a plat of Dalton & Neves, dated March, 1957, said plat being recorded in RMC Office, Greenville County in Plat Book RR, page 20, revised April 6, 1964 and recorded in Plat Book RR, Page 20, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin at joint front corner of Lots Nos. 1 and 2 thence N. 56-22 E. 192.8 feet to an iron pin at joint rear corner of Lots Nos. 1 and 2; thence N. 30-28 W. 111.9 to iron pin on Cannon Lane; thence S. 53-03 W. 173.7 feet to iron pin; thence S. 9-42 W. 36.3 feet with the cord to an iron pin on Bridgewood Avenue; thence S. 33-38 E. 75 feet along Bridgewood Avenue to the beginning point:
