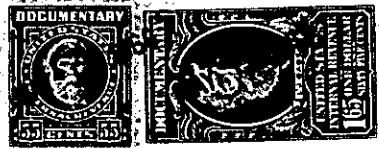

All that piece, parcel or lot of land situate in Greenville County, State of South Carolina, being known and designated as Lot 52 of Wellington Green, Section Two, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book YY at page 117 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Newcastle Way at the joint front corner of Lots 52 and 53 and running thence along the line of Lot 53, S. 6-54 W. 156.3 feet to an iron pin in the line of Lot 34; thence along the lines of Lots 34 and 35, S. 80-0 W. 105.0 feet to an iron pin at the joint rear corner of Lots 51, 52, 35, and 36; thence along the line of Lot 51, N. 7-05 E. 182.5 feet to an iron pin on Newcastle Way; thence along Newcastle Way and following the curvature thereof, the chord being S. 85-35 E. 100.0 feet, to the beginning corner.

The above described property is part of the same conveyed to me by R. C. McCall, et al, by deed dated April 14, 1964, and recorded in the RMC Office for Greenville County in Deed Book 746 at page 543.
