All that piece, parcel or lot of land situate, lying and being on the west side of Robin Hood Road in the City of Greenville, County of Greenville, State of South Carolina being shown as Lot No. 148 on plat of Sherwood Forest made by Dalton & Neves, Engineers, August, 1951, revised through June 1953, and recorded in the R. M. C. Office for Greenville County in Plat Book "GG", at Pages 70 and 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Robin Hood Road, at joint front corner of Lots Nos. 147 and 148, and running thence with the line of Lot No. 147, N. 81-55 W. 179 feet to an iron pin; thence N. 12-50 E. 75.26 feet to an iron pin; thence with the line of Lot No. 149 S. 81-55 E. 172.8 feet to an iron pin on the west side of Robin Hood Road; thence along the west side of Robin Hood Road, S. 8-05 W. 75 feet to the beginning corner.

The above is the same property conveyed to the grantor by deed dated February 5, 1966 and recorded in the R. M. C. Office for Greenville County in Deed Book 791, at Page 340.

As part of the consideration for this conveyance, the grantee herein assumes and agrees to pay the balance due on that certain mortgage to Fidelity Federal Savings & Loan Association dated June 15, 1964 in the original amount of \$18,000.00 recorded in the R. M. C. Office for Greenville County in Mortgage Book 962, at Page 115, the present balance thereon being \$ 17,339.36.
