ALL that lot of land with the buildings and improvements thereon situate on the north-east side of Stephenson Avenue, near the City of Greenville in Greenville County, S.C., being shown as Lot No. 109 on plat of Union Bleachery Village, made by Piedmont Engineering Service, March 1959, recorded in the RMC Office for Greenville County, S.C., in Plat Book QQ, pages 80 and 81, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Stephenson Avenue at the joint front corner of Lots No. 108 and 109 and runs thence along the line of Lot No. 108 N 31-17 E 136.3 feet to an iron pin in the center of a twenty (20) foot alley; thence along center of said alley N 58-35 W 67.4 feet to an iron pin; thence with the line of Lot No. 110 S 31-15 W 136.3 feet to an iron pin on the northeast side of Stephenson Avenue; thence along Stephenson Avenue S 58-37 E 67.4 feet to the beginning corner.
