the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROY M. CHRISTIE & HAZEL L. CHRISTIE, Their Heirs and Assigns:

ALL that certain piece, parcel, lot or tract of land in Butler Township, Greenville County, State of South Carolina, near and East of the City of Greenville, and being known and designated as Lot or Tract Number 17 of a subdivision known as Boiling Springs Estates, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book YY at Pages 14-15, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northern side of Phillips Road at the joint front corner of Lots 17 and 18 and running thence with the Northern side of Phillips Road N 79-43 E 555.1 feet to a point; thence following the curvature of the Northwestern intersection of Phillips Road with Browning Drive (the chord of which is N 31-13 E 26.5 feet) to a point; thence with the Western side of Browning Drive N 17-17 W 362 feet to a point at the joint corner of Lots 17 and 24; thence S 74-44 W 530.6 feet to a point at the joint rear corner of Lots 17 and 24; thence S 10-17 E 333 feet to the point of BEGINNING.
