to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said GLADYS S. RICE, her Heirs and Assigns, Forever:

ALL that lot of land situate on the north side of a proposed 50 foot street and on the south side of Interstate Highway No. 85, near the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 2 on a plat made by Alex A. Moss, December 26, 1962, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south edge of the right of way of Interstate Highway No. 85, said point being 335.3 feet west measured along the said right of way of Interstate Highway No. 85 from the center of the main line track of the Southern Railroad (Columbia and Greenville Division) and runs thence along the south edge of the right of way of Interstate Highway No. 85, N 85-33 W 100 feet to an iron pin; thence S 4-27 W 235 feet to an iron pin on the north side of a proposed 50 foot street; thence along said 50 foot street S 85-33 E 100 feet to an iron pin at corner of other property of the Grantor; thence N 4-27 E 235 feet to an iron pin on the south edge of Interstate Highway No. 85 the beginning corner.

This is a portion of that property conveyed to the grantor herein by deed of The South Carolina State Highway Department, dated December 29, 1962, recorded in the RMC Office for Greenville County, S.C., in Mortgage Book 713, page 348.
