in consideration of FIVE THOUSAND ONE HUNDRED TWENTY-FIVE AND 64/100ths----- Dollars,

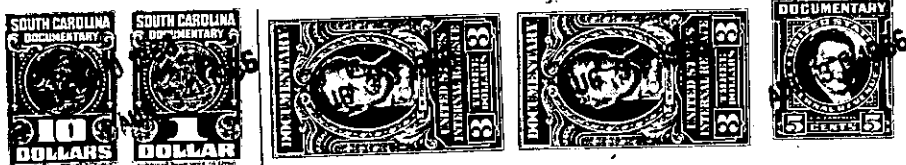
