to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Southside Baptist Church, a South Carolina Eleemosynary Corporation, its successors and assigns,

All that piece, parcel or lot of land in Greenville County, State of South Carolina, in the subdivision known as Kanatenah and situated on the South side of Oregon Street and being known and designated as Lot No. Five of Block A, as shown on plat of property recorded in R. M. C. Office for said County and State in Plat Book F at Pages 66 and 67; said lot of land being described by metes and bounds, as follows:

BEGINNING at a stake on the South side of Oregon Street at the corner of Lot No. 4, as shown on said plat, and running thence along Oregon Street North 63-30 East Sixty feet to a stake at the corner of Lot No. 6; thence along said lot South 26-30 East One Hundred and Sixty-Five feet to a stake; thence South 63-30 West Sixty feet to a stake at the corner of Lot No. 4; thence along said lot North 26-30 West One Hundred and Sixty-Five feet to the place of BEGINNING.
