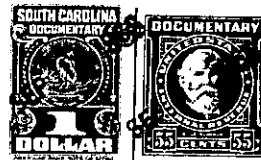

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, near River Falls, South Carolina, being known and designated as the western half of Lot No. 9, as shown on a plat of Pinnacle Lake Development made by J. C. Hill, dated January 18, 1956, revised January 27, 1959, and having, according to said plat, the following metes and bounds, to-wit:
