the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto  
Ann O. Jones, her heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 22 of a subdivision of the property of the grantors as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Ann O. Jones" prepared by Piedmont Engineers and Architects August 26, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Highbourne Drive, joint front corner of Lots Nos. 21 and 22, and running thence with the joint line of said lots, N. 15-03 E. 223.75 feet to an iron pin; thence S. 77-23 E. 355.03 feet to an iron pin at the joint rear corner of Lots Nos. 22 and 24; thence with the joint line of said lots, S. 13-50 W. 220.8 feet to an iron pin on the northern side of Highbourne Drive; thence with the northern side of Highbourne Drive, N. 77-50 W. 360.0 feet to the beginning corner.

This conveyance is subject to utilities easements of record and is also subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 690, Page 531 as amended by subsequent restrictions recorded in Deed Vol. 758, at Page 116.
