All those pieces, parcels or tracts of land in Greenville County, State of South Carolina, being known and designated as Tract No. 6 on plat of property of James R. Gregory recorded in the Greenville County R.M.C. Office in Plat Book 000 at page 57 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point in a county road being the joint corner of tracts nos. 2, 5, and 6 and running thence N 59-25 W. 1,054.8 ft. to a point in Armstrong Creek; thence along Armstrong Creek in a southerly direction, the traverse lines of which are as follows:
