W. F. Gregory, his heirs and assigns forever:

All those pieces, parcels or tracts of land in Greenville County, State of South Carolina, being known and designated as Tract No. 4 on plat of property of James R. Gregory recorded in the Greenville County R.M.C. Office in Plat Book 000 at page 57 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at a point in a county road being the joint corner of tracts nos. 3, 4, and 5 and running thence S 58-13 E. 509.7 ft. to a point; thence N 38-45 E. 200 ft. to the northern corner of tracts nos. 3 and 4; thence along a county road N 51-15 W. 848 ft. to a point; thence N 51-07 W. 207.75 ft. to an iron pin; thence N 19-30 W. 645.9 ft. to a point in Armstrong Creek and running thence with Armstrong Creek in a southerly direction the traverse line of which are as follows:

S 65-55 W. 65.8 ft; S 7-01 E. 58 ft; S 7-01 W. 125.5 ft; S19-05 W. 71.2 ft; S 2-10 W. 59.2 ft; S 34-03 W. 132.4 ft; S9-09 W. 212 ft. to the joint northwestern corner in Armstrong Creek of tracts nos. 4 and 5; thence from said Creek S 63-52 E. 737.5 ft. to a point in a county road; thence S 8-40 E. 180 ft. to point of beginning containing 10 acres more or less.
