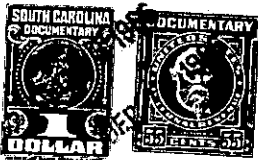
Know All Men by These Presents:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, containing three acres, more or less, on the western side of Highway No. 14 near Mosteller's Mill, three miles north of Greer, being part of Lots Nos. 9 and 10 of Mamie M. Burnett Estate "Mill Tract", and having the following courses and distances:

BEGINNING at a stake on the western side of said highway, at the southeast corner of the property, and running thence N. 84-00 W. 400 feet to a stake; thence S. 60-37 W. 114 feet to the center of a branch; thence a traverse line 28 feet from the branch at this point, N. 48-57 W. 227 feet to stake 42 feet from the center of the branch, the branch being the true line; thence S. 68-46 E. 592 feet from the center of the branch to the west side of said highway; thence S. 13-49 E. 212 feet along the west side of said highway to a bend; thence S. 29-25 E. 163 feet along said highway; to the point of beginning.
