POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, W. Marshall Batson, of the City of Greer, County of Greenville, State of South Carolina, have constituted, made, and appointed, and by these presents do constitute, make, and appoint my wife, Mary Ann Batson, of Greer, South Carolina, as my true and lawful attorney, for me and in my name and stead to act for me and in my behalf in all matters and business in which I have, or may have, any interest whatsoever, with full power and authority, both as to real and personal estates, to sign, execute, perform, and deliver any and all written instruments which, in the judgment of the said attorney, should be signed or executed by me. The power and authority herein given is general and unlimited, but it especially includes the right, power, and authority to the said attorney in my name and stead to ask, demand, sue for, levy, recover, and receive all such sum and sums of money, debts, rents, goods, wares, dues, accounts, and other demands whatsoever which are or shall be due, owing, or payable to me, or detained from me in any manner or ways or means whatsoever, and the special right to deposit in any banking or other financial institution any moneys, by check or otherwise, which I shall be entitled to receive and to withdraw from any such banking or financial institution any moneys which I may have to my credit in such banking or financial institution; and this power shall especially include the right to handle, care for, control, sell, and dispose of any property, real or personal, that I may own, and to purchase for me any property, real or personal, and to execute deeds of conveyance.

The acts of the said attorney, which may be done under and by virtue of this instrument and the terms thereof, I ratify and confirm just as if I were personally present and executed and performed the said acts.
