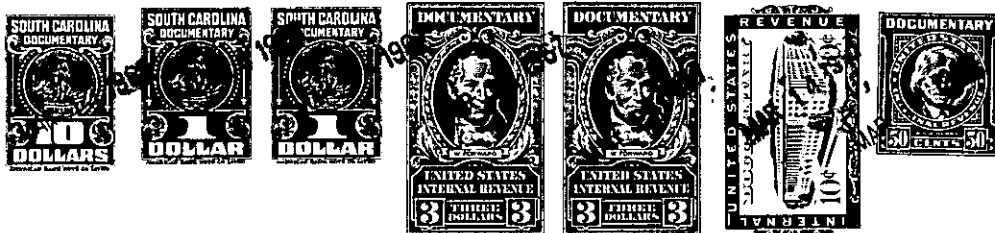

Office for said County in Plat Book 00, page 217, and having the following courses and distances, to-wit: Beginning at a Stake on the North side of said street at the joint front corner of lots nos. 4 and 5 as shown on said plat, and running thence with the North side of said street N.82-09 E.58.7 feet to a Stake, thence N.13-00 W.188 feet to an old Iron Pin, thence S.76-45 W.50 feet to a Stake at the joint rear corner of said lots nos. 4 and 5, thence with the joint property line of said two lots S.10-21 E.182.7 feet to the beginning point.
