KNOW ALL MEN BY THESE PRESENTS, that

WE, GARLAND TOLBERT AND LEE ALICE T. BROCKMAN

in consideration of **Nineteen Thousand and No/100 (\$19,000.00)** ----- Dollars,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **WALTER W. GOLDSMITH AND WILLIAM R. TIMMONS, JR.,** their heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, situate, lying and being on the West side of Haywood Road, sometimes known as Heyward Drive, being shown and designated as the Property of Walter W. Goldsmith and W. R. Timmons, Jr. on a Plat prepared by Carolina Engineering and Surveying Company dated April 13, 1967 and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Haywood Road, sometimes known as Heyward Drive, at the joint front corner of property now or formerly owned by Goldsmith and Timmons and running thence with the West side of Haywood Road S. 15-33 W. 136.1 feet to an iron pin; thence S. 1-28 W. 51.5 feet to an iron pin; thence S. 15-30 W. 200 feet to an iron pin; thence S. 16-48 W. 141.6 feet to an iron pin; thence S. 22-08 W. 209 feet to an iron pin; thence S. 27-13 W. 133 feet to an iron pin at the joint front corner of property now or formerly owned by H. J. Southern, Jr.; thence with the joint boundary of the property of H. J. Southern, Jr. N. 12-45 E. 253.5 feet to an iron pin; thence N. 8-30 W. 231.0 feet to an iron pin; thence N. 6-15 W. 297.0 feet to an iron pin; thence N. 8-30 W. 154.0 feet to an iron pin; thence N. 10-30 E. 180.5 feet to an old iron pin; thence S. 49-41 E. 203.4 feet; thence S. 12-07 E. 100 feet; thence S. 67-56 E. 108.7 feet to the iron pin at the point of beginning.

This is a portion of the property conveyed to James A. Tolbert by the Peoples National Bank on February 9, 1925 by deed recorded in Deed Book 98, Page 53; James A. Tolbert died intestate on June 10, 1938 and the heirs of James A. Tolbert conveyed the above described property to the Grantors in August, 1946 by deeds recorded in Deed Book 308, Page 256 and Deed Book 308, Page 268.

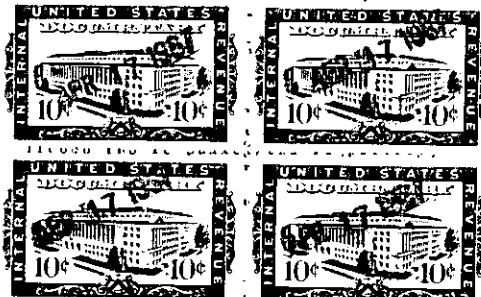
