BEGINNING at an iron pin on the east side of Fourth Avenue, at the corner of Lots 26 and 27; said pin being 80 feet south from the south-east corner of the intersection of Fourth Avenue and Fifth Street, and running thence with the line of Lot No. 27, S. 83-53 E. 122 feet to an iron pin; thence with the rear line of Lot No. 7, S. 6-07 W. 80 feet to an iron pin; thence with the line of Lot 25, N. 83-53 W. 122 feet to an iron pin on the east side of Fourth Avenue; thence with the east side of Fourth Avenue, N. 6-07 E. 80 feet to the BEGINNING Corner.
