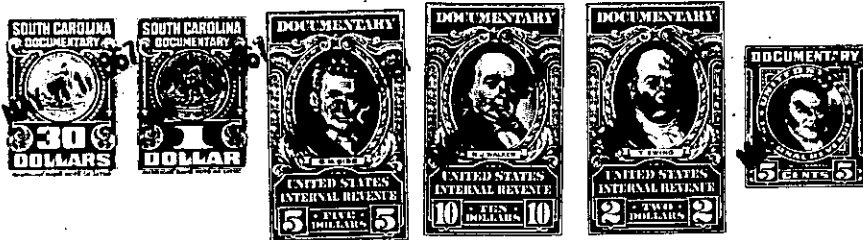
KNOW ALL MEN BY THESE PRESENTS, that Oeland-Simpson Lumber Company

ALL that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northern side of Algonquin Trail being known and designated as Lot No. 4 on a plat of Property of Oeland-Simpson Lumber Company dated March 14, 1964 and recorded in the R.M.C. Office for Greenville County in Plat Book FFF at Page 157 and according to said plat, having the following metes and bounds, to-wit:
