in consideration of One Thousand and No/100 ----- (\$1,000.00) ----- Dollars,

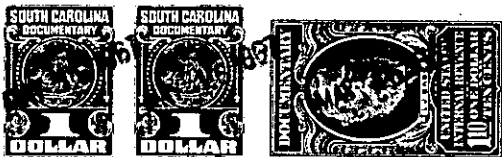
