

parallel to the center line described as follows: Beginning at a point on the west property line now or formerly of Mary B. McWhite South 4° 30' West 725 feet from the northwest corner of said tract; thence South 77° 10' East 581.57 feet to a point in the east property line of the aforementioned tract South 4° 30' West 728.15 feet from the northeast corner of said tract on Whitehorse Road; containing 0.93 of an acre, more or less.

PARCEL NO. 17 (TRACT NO. 33)

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows; Beginning at a point on the western line now or formerly of George Owen property North 4° 30' East 267.35 feet from the southwest corner of said tract; thence South 77° 10' East 307.53 feet to the eastern property line of the aforementioned tract at a point North 12° 13' East 347.55 feet from the southeast corner of said tract; containing 0.49 of an acre, more or less.

PARCEL NO. 18 (TRACT NO. 32)

A 70 foot right of way, 35 feet on each side of the center line of Gantt Station, Greenville Air Base Railroad Spur Line, beginning at Station 71 + 91 of said center line of Spur Line, which station is on the property between the lands of George Owen and Louise Earle, et al.; thence South 77° 10' East, 823.96 feet to Station 80 + 14.96, which is the point of tangent of a 1 degree curve to the right; thence along said curve 115.04 feet to Station 81 + 30.0, which station is on the property line, bearing North 29° 30' East, between the lands of Georgia Ann Harris and Louise Earle, et al., being substantially the same land conveyed by easement from Louise Earle, et al., to the City of Greenville, South Carolina, dated August 31, 1942, recorded September 10, 1942, Deed Book 247, page 166, said easement containing 1.51 acres, more or less.

PARCEL NO. 19 (TRACT NO. 31)

A 70 foot strip of land extending 35 feet on each side of and parallel to the center line described as follows: Beginning with a point on the western property line of property now or formerly of Georgia Ann Harris North 29° 30' East 532 feet from the southwestern corner of said tract; thence along the arc of a 2 degree curve to the right 270 feet to a point on the eastern property line of the aforementioned tract North 29° 30' East 579.4 feet from the southeastern corner of said tract; containing 0.43 of an acre, more or less.

PARCEL NO. 20 (TRACT NO. 30)

A 60 foot strip of land extending 30 feet on each side of and parallel to the center line described as follows: Beginning at a point in center of railway right of way said point being South 29° 30' West 602 feet from the northwest corner of said tract now or formerly of Oscar Townes in center of Whitehorse Road, and running thence South 69° 28' East 361.65 feet to a point in the center of right of way on east boundary of land now or formerly of Oscar Townes, on the west boundary line now or formerly of Sam Rosemond;
