the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alice Elmira Scott, her heirs and assigns forever:

All that certain piece, parcel or lot of land, situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on Davis Road, and being shown as Lot No. 1 on a plat of the Genever Adams Estate, by Carolina Engineering & Surveying Company dated April 7, 1967, recorded in Plat Book RR at page 166 in the Office of The R. M. C., for Greenville County, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Davis Road as shown on the plat and running thence along said Davis Road S. 74-34 W. 49.4 feet to a pin and S. 41-06 W. 130 feet to a pin; thence N. 2-51 W. 260.2 feet to a branch; thence along said branch with the branch being the line N. 57-03 E. 97.6 feet and N. 38-20 E. 135 feet to an old iron pin; thence S. 3-34 W. 309 feet to an iron pin on Davis Road, the beginning corner.

Being a portion of the property conveyed to Genever Adams (Nesbitt) by deed dated April 2, 1951 and recorded in Deed Volume 432 at page 63 in the Office of the R. M. C. for Greenville County. Genever A Nesbitt subsequently died testate and this conveyance is made pursuant to paragraph II of her Will as noted in the Probate Court for Greenville County in apartment 966, File 6.

This conveyance is made subject to a 20 foot drive easement as shown on the plat referred to herein.
