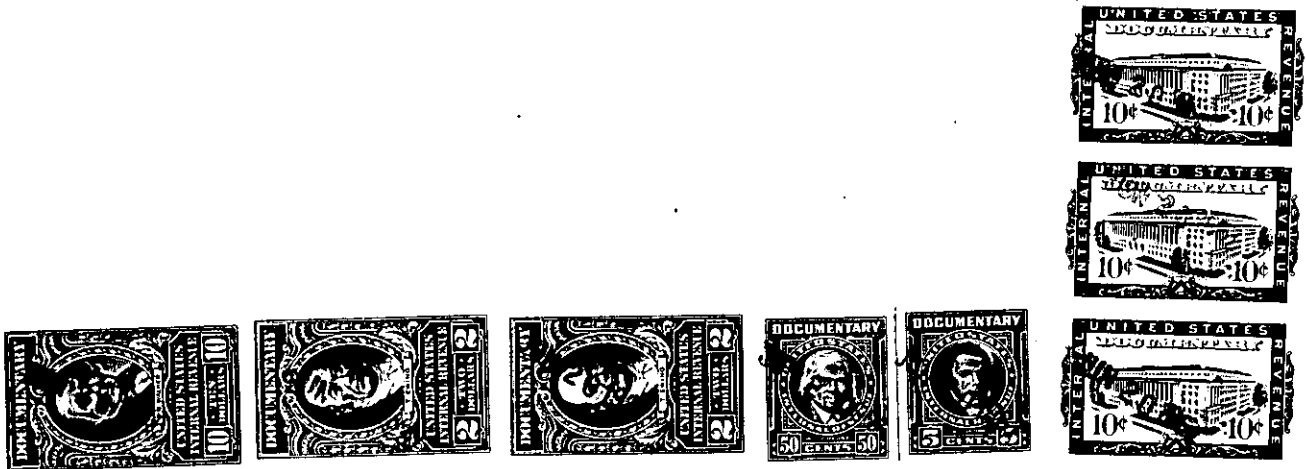
KNOW ALL MEN BY THESE PRESENTS, that I, JAMES A. SMOTHERS,

Office for Greenville County, Plat Book R#1, Pages 106-7, and having according to said plat, the following metes and bounds, to-wit:
