An undivided one-half (1/2) interest in and to:

All that piece, parcel or lot of land situate, lying and being on the North-western side of Bradley Boulevard in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 103 as shown on a plat of University Park, prepared by Dalton & Neves, Engineers, dated November, 1946, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book P at page 127 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Bradley Boulevard at the joint front corner of Lots Nos. 102 and 103 and running thence with the line of Lot No. 102 N. 37-34 W. 182.5 feet to an iron pin; thence with the rear line of Lot No. 111 S. 52-26 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 103 and 104; thence with the line of Lot No. 104 S. 37-34 E. 182.5 feet to an iron pin on the Northwestern side of Bradley Boulevard; thence with the North-western side of Bradley Boulevard N. 52-26 E. 75 feet to the point of beginning.
