TRAMMELL and CHARLES C. FAYSSOUX**, their heirs and assigns:

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number One Hundred Three (103) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in Plat Book "JJJ" at page 71; and having according to said plat the following metes and bounds:

BE GINNING at an iron pin on the North side of Bartram Grove at the joint front corners of Lots 104 and 103 and running along said lot lines thence N 38-33 E 158.1 feet to an iron pin; thence turning and running along the rear lot line of Lot 103 S 51-53 E 120 feet to an iron pin; thence turning and running along the joint lot lines of Lots 103 and 102 S 38-33 W 159 feet to an iron pin on the North side of Bartram Grove, thence turning and running along Bartram Grove N 51-27 W 120 feet to the point of beginning.
