in consideration of Twenty-five Thousand and no/100 (\$25,000)----- Dollars,

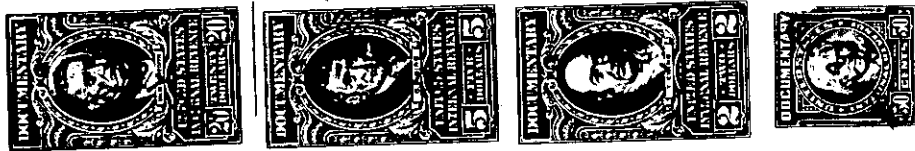
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
