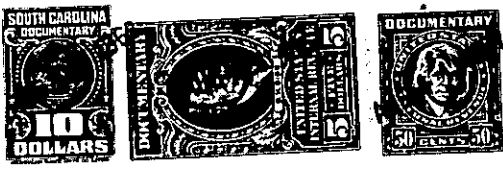
in consideration of Five Thousand and No/100 ----- Dollars,
