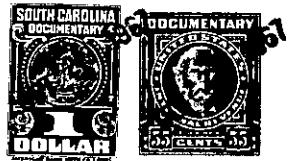

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM C. BARKSDADT AND KATHERINE G. BARKSDADT, Their Heirs And Assigns Forever.

All that certain piece, parcel, or lot of land, with the improvements thereon, situate, lying and being in Paris Mountain Township, County of Greenville, State of South Carolina, which is a portion of Lot 17 of Highview Acres Subdivision, a plat of which is recorded in the Office of the R.M.C. for said County in Plats Book 0, Page 123. This property conveyed hereby is shown and described more particularly on a plat of the Property of H. G. Barnett, prepared by Terry T. Dill, R. L. S., October 11, 1967, as follows.

BEGINNING at a point in the southernmost line of Lot No. 17, which point is N. 84-30 W. 340.9 feet from the western edge of Courtland Drive and running thence N. 84-30 W. 79 feet to a point; thence N. 5-25 E. 200 feet to a point; thence S. 84-30 E. 80 feet to a point; and, thence S. 5-08 W. 200 feet to the point of beginning. This lot is shown and designated as Lot 17C on the above-mentioned plat prepared by Terry T. Dill.

This conveyance is made subject to any existing and recorded easements, rights-of-way, and protective covenants or restrictions.
