Hundred and No/100-----(\$1,200.00)----- Dollars,

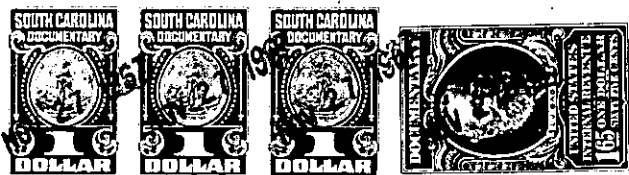
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto LINDSEY BUILDERS, INC., its successors and assigns forever:

ALL that piece, parcel or lot of land, situate, lying and being in the  
State of South Carolina, County of Greenville, at the Northwestern corner of  
the intersection of Bridge Road with Pauline Street, near Taylors, being shown  
as Lot No. 1, on a Plat of Section 1 of the Subdivision for BURLINGTON INDUSTRIES,  
INC., made by Piedmont Engineers & Architects, dated October, 1964, and recorded  
in the RMC Office for said County and State in Plat Book JJJ, page 10, and having  
according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Bridge Road at the joint front  
corners of Lots Nos. 1 and 2, Section 1, and running thence along the common  
line of said lots, N. 7-16 E., 207.8 feet to an iron pin; thence S. 78-45 E.,  
68.3 feet to an iron pin on Pauline Street; thence with the curve of the Western  
side of Pauline Street, the chord of which is S. 11-28 E., 147.4 feet to an iron  
pin at the intersection of said street with Bridge Road; thence with the Northern  
side of Bridge Road, S. 68-23 W., 131.6 feet to an iron pin, the beginning corner.

The above described property is the same as Parcel No. 4 conveyed to the Grantor  
by deed of Burlington Industries, Inc., recorded in the RMC Office for said County  
and State in Deed Book 800, page 291, and is hereby conveyed subject to the re-  
strictions and reservations contained therein.
