having according to said plat, the following description, to-wit:

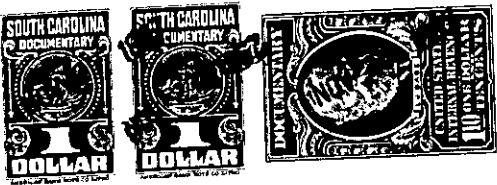
LOT 41 Marlana Avenue:
