in consideration of the sum of One Hundred Sixty Seven (\$167.00)-----

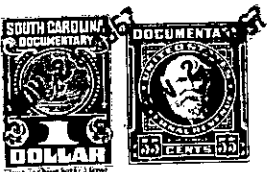
in the State aforesaid, DOLLARS,
