ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number One Hundred Fifty-Six (156) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965; and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at page 71; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Southeast side of Chapman Road at the joint front corners of Lots 157 and 156 and running thence S 42-06 E 172 feet to an iron pin; thence turning and running along the rear lot line of lot 156 S 54-39 W 155 feet to an iron pin; thence turning and running N 38-15 W 158.1 feet to an iron pin on Chapman Road; thence turning and running along Chapman Road N 50-43 E 30 feet to an iron pin; thence continuing along Chapman Road N 49-09 E 113.4 feet to the point of beginning.
