All that certain piece, parcel or lot of land, situate, lying and being on the northern side of Forestdale Drive, in Chick Springs Township, Greenville County, South Carolina near the City of Greenville, being shown and designated as Lot No. 21 and the eastern half of Lot No. 20 of FORESTDALE HEIGHTS on plat thereof made by R. K. Campbell, Engineer, December, 1956, reference to which is craved for a more complete description thereof, and recorded in the R. M. C. Office of Greenville County in Plat Book KK, at Page 199.
