ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, located near St. Mark M. E. Church (Colored) lying on the south side of the road that leads from Loftis' Packing Shed to J. W. Greer's Store, being shown and designated as Lot No. 4 on a plat of property of James H. Priestly Estate made by H. S. Brockman, Surveyor, October 23, 1947, and having the following courses and distances to wit:
