ALL water lines, mains, valves and appurtenances installed and located in, under or along Pemberton Drive and Pemberton Court in Montroyal Hills Subdivision in the County of Greenville, State of South Carolina, and specifically including approximately 1,869 feet - 2" pipe; 3 - 2" Valves; as shown on a drawing entitled "B.E. Huff and H.Z. Jones to Berea Public Service District", attached hereto and made a part of this conveyance.

TOGETHER with all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines, and appurtenant equipment.
