THIS AGREEMENT OF ASSIGNMENT, Made and entered into this 4<sup>th</sup> day of December, A. D., 1963, between ATLANTIC COAST LINE RAILROAD COMPANY, a corporation under the laws of the State of Virginia, party of the first part, and SIMPSONVILLE-MAULDIN-FOUNTAIN INN WATER DISTRICT, a public service district, party of the second part, WITNESSETH:

WHEREAS, by an indenture dated August 31, 1963, recorded in Deed Book 731, page 249, Office of the Register Mesne Conveyance, Greenville County, South Carolina, between R. C. Collins, of Greenville County, South Carolina, and the Atlantic Coast Line Railroad Company, said R. C. Collins granted, bargained, sold and conveyed unto the Atlantic Coast Line Railroad Company, its successors and assigns, a right of way and easement of sufficient width for the installation, maintenance, operation, use and presence of an 8-inch water pipe line on that certain strip of land situate, lying and being near the Town of Mauldin, County of Greenville, State of South Carolina, as more particularly described in said indenture to which reference is hereby made; and

WHEREAS the Atlantic Coast Line Railroad Company desires to assign said indenture to Simpsonville-Mauldin-Fountain Inn Water District; and

WHEREAS Simpsonville-Mauldin-Fountain Inn Water District is agreeable to such assignment;

NOW THEREFORE the parties hereto mutually agree, that effective October 24, 1963, said indenture dated August 31, 1963, be and is hereby assigned from the Atlantic Coast Line Railroad Company to Simpsonville-Mauldin-Fountain Inn Water District.

And Simpsonville-Mauldin-Fountain Inn Water District, in consideration of the premises, hereby agrees that it will, upon receipt of said assignment, assume all of the responsibilities of the Atlantic Coast Line Railroad Company under said indenture.
