Whereas, under and by virtue of the laws of the State of South Carolina, the City of Greenville is authorized to levy taxes and assess property within the limits of said city for taxation, and upon default in the payment thereof to issue under the hand and seal of the Clerk of the City Council of the City of Greenville an execution directed to some officer designated for the collection of delinquent taxes, requiring and commanding him to levy the same by distress and sale of so much of the defaulting taxpayers' estate, real, personal, or both, as may be sufficient to satisfy the taxes and charges thereon so levied and assessed; and further that said officer may take possession of such property and after due advertisement, sell and dispose of the same as in such cases provided by law, make titles thereto and put the purchaser in possession,

And, whereas, there appears on the Tax Books of said City for the fiscal year 1967 certain real estate consisting of

Seventeen and 39/100 Dollars;

Whereas, the above named Dan Moyd and Jack Moyd
having neglected to pay the City of Greenville the above taxes, assessments and penalties as provided by law, an execution was issued therefor, on the 3rd day of May 1967
and lodged with the Delinquent Tax Collector of said City.

And, whereas, in accordance with law, said Delinquent Tax Collector did seize, levy upon, advertise for sale, and did on the 5th day of June 1967 sell the same at public auction to the highest bidder, for cash, and one George J. Howard became the purchaser and complied with the terms of sale.

Now, therefore, I, L. E. Spann, Delinquent Tax Collector for the City of Greenville, for and in consideration of the foregoing premises and the sum of Eight Hundred Ninety Seven and no/100 Dollars, have granted, bargained, sold and released and do hereby grant, bargain, sell and release unto the said George J. Howard his heirs and assigns,

All that certain lot of land in the City of Greenville, on Lowndes Hill Road, and described as follows:

BEGINNING at an iron pin on Lowndes Hill Road and running thence along the line of Lowndes Hill Road, N. 88-28, W. 260 feet to the edge of a right of way acquired by the South Carolina Highway Department; thence in a northeasterly direction with the line of said right of way, 285 feet; thence S. 17-29, E. 230 feet to an iron pin on Lowndes Hill Road, the beginning corner.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To Have and to Hold all and singular the Premises before mentioned unto the said GEORGE J. HOWARD heirs and assigns forever.
