That I, J. T. Farmer, in the State aforesaid, in consideration of the sum of One (\$1.00) - - - - - DOLLARS, and love and affection,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) J. Carrol Pittman and Anlee Farmer Pittman and their heirs and assigns forever:

All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, located about 7 miles north from the City of Greer, located near the Jordan Road and about 1/4 mile south therefrom, lying on the west side of a County road which leads southward from said Jordan road, being all of Tract No. 1 as shown on a plat made for A. I. Farmer by Terry T. Dill, Surveyor, dated June 19, 1967, and having the following courses and distances:

BEGINNING on a stake in said County road (iron pin on west bank of said road at 11 feet from true corner), corner with the Pittman land, and runs thence with the Pittman line, S. 85-30 E. 156.9 feet to an iron pin, corner of Tract No. 3; thence with the line of Tract No. 3, S. 21-06 E. 560 feet to an iron pin, corner of Tract No. 2; thence with the line of that tract, N. 71-23 W. 484.4 feet to an iron pin on the west side of said County road; thence N. 14-03 E. 381.6 feet to the beginning, containing 3.06 acres, more or less.

Subject, however, to an easement or right-of-way 20 feet in width and extending along the northern part of the tract conveyed herein, as set forth in deed of A. I. Farmer and J. T. Farmer to Anlee Farmer Pittman.

This is the same property conveyed by J. T. Farmer and Anlee Farmer Pittman to A. I. Farmer by deed recorded in Deed Book 826, page 649, R.M.C. Office for Greenville County. The said A. I. Farmer died intestate on January 3, 1968 and the said J.T. Farmer and Anlee Farmer Pittman are his only heirs at law.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors, and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
