KNOW ALL MEN BY THESE PRESENTS, that R.M.D.R. L. Owings

in consideration of \$1.00, love and affection for my mother Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Emma Owings, for and during her natural life,

All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, Greenville Township, near the City of Greenville, and having the following metes and bounds, to wit:

BEGINNING at a point 150 feet from the corner of property now or formerly of J. P. Owings and Bent Bridge Road, and running N. 5 W. to a point; thence W. to line of property now or formerly of J. P. Owings; thence 500.2 S. 14 W. to Bent Bridge Road; thence along the said Road 150 feet to the beginning corner, according to plat made by W. D. McBrayer. Being Lot No. 1 of the J. P. Owings property.

Being the same property conveyed to the grantor by deed of J. P. Owings, recorded in Volume 217 at Page 282 in the RMC Office for Greenville County.

Upon the death of the said Emma Owings, title to the above described property shall vest in the seven children of J. P. Owings, deceased, named in his will, filed as Apartment 598, File 58 in the office of the Probate Judge for Greenville County. The purpose of this deed is to vest in Emma Owings a life estate of record, then upon her death a fee simple title to the children of J. P. Owings, in accordance with his will.

Less, however, that strip of land crossing said lot which was deeded to S. C. Highway Department and now is a part of S. C. Highway 123.
