ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, County of Greenville, State of South Carolina, designated as Lot No. 10 on a revised plat of Section Number 1 of Belle Terre Acres, prepared by C. O. Riddle, R. L. S., August 29, 1967, recorded in the R. M. C. Office for Greenville County in Plat Book 000 at Page 106, said lot containing 1.27 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the western side of West Fairway Drive at the joint front corner of Lots No. 9 and 10, and running thence along the line of Lot No. 9 N. 38-56 W. 276.4 feet to an iron pin; thence N. 49-22 E. 199.9 feet to an iron pin; thence along the line of Lot No. 11 S. 38-56 E. 274.5 feet to an iron pin; thence along West Fairway Drive S. 47-54 W. 100 feet to an iron pin; thence S. 49-57 W. 100 feet to the point of beginning.

This being a portion of the property conveyed to the grantor by a certain deed recorded in the R. M. C. Office for Greenville County in Deed Book 459 at Page 528. The grantor to pay the 1968 County taxes on said property.

This property being subject to the protective covenants recorded in the R. M. C.
