in consideration of Four Hundred and No/100 (\$400.00) ----- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Will Edwards, his heirs and assigns forever:

ALL that piece, parcel or lot of land located, situate and being in Cleveland Township, Greenville County, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at a point on the norther edge of Storey Street bounded on the west by lands of Granville Buchanan, thence running with the lands of Granville Buchanan N. 36-21 W. 100 feet to an iron pin at the joint corner of lands owned by Pritchett and Granville Buchanan; thence running with Pritchett land N. 60-15 W. 200 feet to the western edge of Storey Street; thence following the western edge of said Storey Street about 250 feet to the beginning corner.

It is the intention of the grantor to convey all the property that he presently owns north of Storey Street to the grantee.
