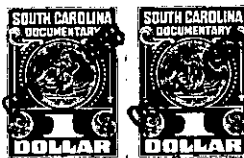
The above is the same property conveyed to the grantor by deed dated and recorded in the R. M. C. Office for Greenville County in Deed Book 853, at Page 191.
