the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

unto JAMES H. BISHOP, JR., his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot 17 on Plat of Oakforest Sub-division, plat of which is recorded in Plat Book CCC, Page 41, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Oakforest Drive at Joint front corner of Lots 16 and 17 and running thence with the line of said lots, S. 77-44 W., 150 feet; thence S. 12-16 E., 163.2 feet to a point on Ridge Road; thence with Ridge Road N. 56-15 E., 44.8 feet; thence continuing with Ridge Road, N. 70-50 E., 83.8 feet to curve at the intersection of Ridge Road and Oakforest Drive; thence with said curve (the chord of which is N. 29-30 E.) 36.8 feet to a point on Oakforest Drive; thence with Oakforest Drive, N. 12-16 W., 109.3 feet to the point of beginning. A small triangle in the above described property was conveyed to Grantor by Deed recorded in Deed Book 725, Page 296. See also Plat Book DDD, Page 87.
