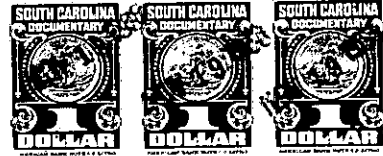

assigns forever:

All my right, title and interest in and to the following described

Tract 1 All that certain piece, parcel and lot of land situate, lying
and being on the South side of Trade Street and on the East side of
Neely Ferry Road (South Street) in the Town of Simpsonville, County of
Greenville, State of South Carolina and having the following courses
and distances to-wit:

corner with property now or formerly of Vaughn and running thence
along the South side of Trade Street S. 79 W. 161.84 feet to a point;

(South Street); thence along the center of said Neely Ferry Road

N. 30- 1/2 E. 141.9 feet to a point; thence N. 33 1/2 E. 33 feet to a

238.26 feet to a point; thence N. 30 1/2 E. 277.2 feet to a point;
thence N. 75 E. 314.82 feet to a point on the West side of Main
Street (Greenville-Laurens Highway) which is parallel to the right
