ALL water lines, mains, valves and appurtenances installed and located in under or along Galphin Drive and Hillrose Avenue, County of Greenville, State of South Carolina including approximately 879 feet more or less-3" Galv. Pipe, 2-3" Valves and is shown on a drawing entitled, "Grady Greer and John G. Wilson to Wade Hampton Water and Sewer District," attached hereto and made a part of this conveyance.

AND ALSO all water lines, mains, valves and appurtenances installed and located in under or along Acorn Court, County of Greenville, State of South Carolina including approximately 365 feet more or less -2" Galv. Pipe, 2-2" Valves and is shown on a drawing entitled, " John G. Wilson and Grady Greer to Wade Hampton Water and Sewer District," attached hereto and made a part of this conveyance.
