the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto The Liberty Corporation, a South Carolina corporation, its successors and assigns forever:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, on the North side of Buncombe Street, and being more particularly described as follows: Beginning at an iron pin on the North side of Buncombe Street at the corner of the property now or formerly owned by the Standard Oil Company, which iron pin measures approximately 129.1 feet, more or less, East from the intersection of Buncombe Street and Atwood Street and running thence along Buncombe Street South 32 degrees 40' East 102 feet, more or less, to pin at corner of property now or formerly owned by the Coca Cola Bottling Company; thence along the line of the said Coca Cola Bottling Company property North 48 degrees 42' East 269.1 feet, more or less, to iron pin at corner of property now or formerly owned by S.
