State of South Carolina, in consideration of Four Thousand Four Hundred and No/100-----

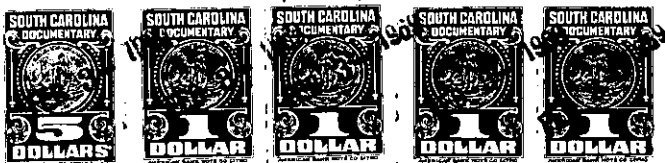
