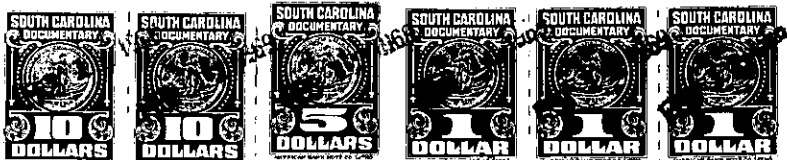
in consideration of Fourteen Thousand Five Hundred (\$14,500.00) - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Reid Sullivan and Sweetie D. Sullivan,

All that certain piece, parcel or lot of land situate, lying and being in the state of South Carolina, county of Greenville, Gantt Township, being known and designated as Lot No. 8 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co., October 1963, and recorded in the RMC Office for Greenville County in Plat Book RR at page 199, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Dunlap Drive, joint front corner of Lots 8 and 9 and running thence along the joint line of said lots, S. 66-25 E. 131.9 feet to an iron pin on the subdivision property line; thence along the subdivision property line, N. 23-35 E. 166.5 feet to an iron pin, joint rear corner of Lots 7 and 8; thence along the joint line of said lots, S. 74-56 W. 198.8 feet to an iron pin on the northeastern side of Dunlap Drive, thence along the northeastern side of Dunlap Drive, following the curvature thereof, the chord being S. 5-44 E. 48 feet to the beginning corner.

This is the same lot conveyed to grantor by Ward S. Stone by deed recorded July 8, 1968 in deed vol. 848 page 42 of the RMC Office for Greenville County, S. C. and is conveyed subject to restrictions recorded in deed vol. 771 at page 223 and to utility and drainage easements.
