Bell," the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of View Point Drive at the joint front corner of the premises herein described and property now or formerly of Charles W. Bell and Annie W. Bell, and running thence with the said property now or formerly of Charles W. Bell and Annie W. Bell N. 32-30 W. 102.3 feet to an iron pin; thence N. 57-30 E. 15.7 feet to an iron pin on the western side of a 30 feet private road (Dogwood Trail); thence with the western side of a 30 foot private road (Dogwood Trail) S. 10-51 E. 20 feet to an iron pin; thence continuing with the western side of a 30 foot private road (Dogwood Trail) S. 26-48 E. 84.1 feet to the point of beginning.
