KNOW ALL MEN BY THESE PRESENTS, that We, ALVIS BROOKS, individually and as Trustee, MAUDE BROWN, BILLY BROOKS, JANE BROOKS PORTER, JERRY BROOKS, ED BROWN and CAROLINE BROWN LAWSON,

in consideration of \$1.00 and correction of description Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ALVIS BROOKS, his heirs and assigns forever:

All that certain piece, parcel or lot of land in the Town of Simpsonville, Greenville County, State of South Carolina, on the Easterly side of East South Main Street, being shown as Lot No. 1 of Plat entitled, "Property of Alvis Brooks, et al.", prepared by C. O. Riddle, dated October, 1968, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on the Easterly side of East South Main Street, a joint front corner with property of Mark Brown and Maude B. Brown, and running thence with the Easterly side of said street, N. 3-02 W., 127.4 feet to an iron pin at joint front corner of L. Alfred Vaughn, running thence with said Vaughn property, N. 81-00 E., 240 feet to an iron pin; thence S. 3-00 E., 40 feet to an iron pin; thence S. 10-25 E., 113.1 feet to an iron pin; thence S. 86-58 W., 253.3 feet to an iron pin, the beginning corner.
